1. Provide FREEWORLD BRAND with a Purchase Order | ICPO directly from the buying entity or procurement agency which can be any of the following entities: Major Hospital, Municipality, Government, Major Medical Supplier and or distributor.
  - a. **NOTE:** Procuring entities must provide directly to FWB Supplier current and past transaction completed along with a letter of authorization. FWB Supplier reserves the right to accept or reject any PO | ICPO.

FWB SUPPLIER will require the following information from the procuring entity.

- Official procurement attestation letter.
- Official Purchase Order
- Past performance contract or agreements related to transactions of this nature
- For third party contractors, we will require Solicitation Commercial award letter awarded to the contractor from a government or municipality.
- FWB Supplier Do Not Require Any Deposit | No POF | No SBLC
- Based on the information provided, FWB Supplier will conduct its due diligence and based on the resultant of such due diligence will elect to proceed to steps 2, 3, 4, 5 and 6.

2. FWB SUPPLIER will provide a Full Corporate Offer (FCO) to procuring entity.
3. FWB SUPPLIER and Procuring entity executes Purchase and Sale Agreement – The governing document that will used to shepherd the transaction | deal.
